MINUTES of the Council Meeting held on Monday 2nd September 2019, at 7.30 pm in the Lower Town Hall.

Present: Cllrs Adams, Burton, Faraday, Handford, Hill, Marshall, Stannard, Taylor & Wills. District Councillor Brockbank. County Councillor Ireton. The Clerk Christine Downey. PC Grace. Three members of the public.

- 68 To Receive Apologies from members unable to attend
Cllrs Bridgeman and Swales. DCllr Handley.
- 69 To Receive and Record any member's Disclosable Pecuniary Interest in relation to any items on the agenda and to receive and decide members requests for DPI dispensations
Cllr Marshall declared an interest in item 76.1.2 planning application, 2019/20843/HH Proposed demolition of existing utility room, and construction of garden room and glazed link at Bentham Hall, Maim Street, High Bentham, Lancaster, LA2 7HS.
Cllrs Faraday and Wills declared an interest in the same item 76.1.2.
- 70 To Receive Comment & Concerns
A question was raised regarding the grass cutting arrangements at the playing fields. It was explained that the council have contracted somebody to cut the grass, but that the contractor does not cover collection of the cut grass. The contract is for three years. The first cut this year was not until mid-April which meant that the field was very long before that first cut.

PC Jayne Grace reported that the car parking problems in Low Bentham have been addressed. Four vehicles that were clogging up the Low Bentham car park were reported to Craven DC, DVLA and the environmental health dept, and have now been removed. Parking enforcement is now involved.
It was reported that there is a problem with cars speeding and overtaking dangerously on Springfield. Usually early evenings between 7 pm and 10 pm, or on Saturday afternoons. PC McClurg has arranged the use of a speed gun and will be asked to do enforcement on Springfield.
- 74 To receive Reports from Cllrs & DCllrs (for information only)
DCllr Ireton informed the meeting that NY have asked for MP's backing for a challenge on a school transport matter. NY currently raise income by selling spare seats on school transport, i.e. they sell those seats not filled by entitled children. But this is under threat because the coaches on which the spare seats are sold need to be wheelchair accessible and they are not. This could result in £300,000 of lost revenue. School transport currently

costs approx. £23.5 million in NY, and is under pressure partly because of barn conversions in remote locations, which result in children needing to be transported by taxi.

A question was raised regarding whether the increased cost of transporting children to schools further afield was factored in when local school closures were made, for example Horton-in-Ribblesdale school. DCllr Ireton did not have the costs involved to hand but assured the meeting that this will have been taken into account, and that the increased costs of transport as a result of closing local schools will have been balanced out by the other cost savings as a result of the closures.

An Ofsted report is awaited on Clapham school, which might not be very good, in light of recent staffing problems.

DCllr Brockbank informed the meeting that Craven DC are marking the boundary with signs. The Craven boundary has never been marked before, the purpose is to promote Craven, and the cost is £6,902.91 for the whole of Craven.

She has been speaking with Stacey Griffin (Police Community Support Officer) regarding antisocial behaviour in Bentham. The police have been asked to improve or increase patrols, particularly in the area around Grasmere Drive, Grasmere Close, and Grasmere car park. The fact that we need more police officers has been raised at the Police and Crime Committee.

DCllr Brockbank further informed the meeting that she had received complaints regarding five camper vans parked permanently in the car park, one of which has been there for a considerable time. She has reported the matter to Craven DC. It was thought that this issue would be best addressed if the current parking restriction (23 out of 24 hours only) was enforced; and that a height barrier could have a negative impact, as it could prevent tourists in camper vans who were passing through Bentham from stopping off here.

DCllr Brockbank was asked to pursue three matters with Craven DC: The parking problem; assistance with the dog fouling problem including the use of camera's as offered at an earlier date by DCllr Thompson; and the antisocial behaviour problem. It was pointed out that use of the camera's was offered quite some time ago, that the offer has been taken up by the council but that the use of the cameras continues to fail to materialise.

To receive an update on the position regarding the trees at the Extra Care Housing scheme. DCllr Brockbank reported that she had toured the extra care housing site with the architect after the conclusion of the recent meeting on the site, and that she had explained to him that the proposed (and approved) planting is possibly not the best design that can be achieved.

Cllr Adams reported that the Caroline Hay, regional manager for Housing 21 who are building the extra care housing scheme, and the Extra Care Group are meeting at 11.30 am on Monday 16th September, and that a representative from Bentham Town Council has been invited to attend. Cllr Handford agreed to check if he is available to go. (He later confirmed that he is, and will attend).

DCllr Brockbank emphasised that if all three interested parties (Housing 21; Extra Care Group; Bentham Town Council) can agree on a revised and improved planting scheme that it may be possible for it to be adopted. That at the very least suggestions should be agreed and submitted for consideration.

There are two street lights still be lit on Duke street. Peter Ball of NYCC advises that instructions were issued to the contractor on 14th Aug, on a 30-day notice, so it should be completed by 14th September. Two street light in Grasmere Drive that were precepted for are next. One more to do on Wenning Ave, by Mayfield Rd, LP7, ducting is in.

There are overhanging bushes and trees by the bus stop at the bottom of Robins Lane. The bushes are so far out into the road that the bus cannot get in to the stop properly, and children are having to walk into the road to board. Seems to be no's 1 to 7 Robins Lane.
RESOLVED: Clerk to report to NYCC highways department who will write to the landowner.
There are blocked gullies in Goodenber Road and on Station Road; the gullies on Low Bentham Road are full; and the recent map purporting to show which gullies have been cleaned this year by NYCC is not correct. It was noted that in some instances the gullies have been cleaned and the drains are the problem. But there are many instances where the gullies are the problem as they are full.

The road markings have not been reinstated after the recent road surfacing. The lining team did some work but much is unfinished, particularly outside the school, which is disappointing as the school returns next week. The zigzags and parking restriction markings have gone.

Toll House. The road on the left going toward Lancaster needs repairs. It's where NY did a culvert.
RESOLVED: Clerk to report.
A group of volunteers have recently repaired the footpath along the North side of the river, from Low to High Bentham, and the Town Council would like to congratulate them on their hard work. It was reported that they need a further 4 tons of gravel to complete the task. CClIr Ireton requested that they send him an email and he will forward a form for a grant to cover the cost. His advice was to ensure that they request sufficient funds to complete the entire job on the one application.
